This letter has been issued to officially acknowledge that **Microsec Micro Software Engineering & Consulting Limited** (short name: **Microsec Ltd.**, Hungarian name: **Microsec Számítástechnikai Fejlesztő Kft.**, short Hungarian name: **Microsec Kft.**, address: **H-1022 Budapest, Marczibányi tér 9.**, company registration number: **01-09-078353**, registered by **The Metropolitan Court of Budapest as Company Court**, hereinafter referred to as "**Microsec**") has been registered pursuant to Art. 6., Paragraph 1 and Article 17., Paragraph 1, point a) of the Hungarian Act on Electronic Signatures No. 35 of 2001 (hereinafter referred to as "**the Act**") as a qualified service provider in the following fields:

- Certification service provider
- Time-stamping service provider
- Provider of signature-creation devices and related services to end-users
- Electronic archival service provider

Microsec has been registered as a non-qualified service provider in the following fields:

- Certification service provider
- Time-stamping service provider
- Provider of signature-creation devices and related services to end-users

(hereinafter referred to as "**the Services**")

In the above fields, The Services of Microsec are under the supervision of the National Communications Authority, Hungary (hereinafter referred to as "**the Authority**"). The



objective of the supervision is to ensure compliance with the Act and other binding Hungarian legal regulations, with relevant generally recognised standards voluntarily applied by Microsec and with the terms and conditions governing the Services. In the course of supervision, the Authority continuously checks the fulfilment of the relevant requirements and handles any reported changes concerning the data in its register. With regard to the qualified Services of Microsec, the Authority performs a comprehensive on-site visit at Microsec's premises pursuant to Article 20, Paragraph 4 of the Act once in a year. The date of the last visit was **8<sup>th</sup> and 9<sup>th</sup> October 2007**, the next visit is scheduled for **Autumn 2008**. The requirements contained in the Act and the other binding Hungarian legal regulations are based on, or compatible with, the **Directive 1999/93/EC of the European Parliament and of the Council of 13 December 1999 on a Community framework for electronic signatures** and generally recognised European standards in the area of electronic signatures, in particular **ETSI TS 101 456** and **ETSI TS 102 042**.
